

SUMMARY ANNUAL REPORT  
FOR  
CENTRAL LABORERS' WELFARE FUND

This is a summary of the annual report for the Central Laborers' Welfare Fund, (Employer Identification No. 37-6058345, Plan No. 501) for the period January 1, 2022 to December 31, 2022. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

The Board of Trustees has committed itself to paying medical, dental, vision, disability and death benefits and other benefit claims under the terms of the plan.

INSURANCE INFORMATION

The Plan has contracts with Metropolitan Life Insurance Company to pay certain Death and Accidental Death and Dismemberment Benefit claims incurred under the terms of the Plan. The total premiums paid for the Plan Year ending December 31, 2022 were \$39,521.00.

The Plan has contracts with Blue Cross Blue Shield to pay certain Medical Benefit claims incurred under the terms of the Plan.

BASIC FINANCIAL STATEMENT

The value of the Plan assets, after subtracting liabilities of the Plan, was \$33,363,416 as of December 31, 2022 compared to \$41,925,912 as of January 1, 2022. During the Plan Year the Plan experienced a decrease in its net assets of \$8,562,496. This decrease includes unrealized appreciation or depreciation in the value of the Plan assets; that is, the difference between the value of the Plan's assets at the end of the year and the value of the assets at the beginning of the year, or the cost of assets acquired during the year. During the Plan year, the Plan had total income of \$14,859,588. This income included employer contributions of \$18,302,971, employee contributions of \$1,116,885 and earnings from investments of \$-4,947,600. Plan expenses were \$23,422,084. These expenses included \$2,284,013 in administrative expenses and \$21,138,071 in benefits paid to participants and beneficiaries.

You have the right to receive a copy of the full annual report, or any part thereof, on request. The items listed below are included in that report:

1. An accountant's report;
2. Financial information and information on payments to service providers;
3. Assets held for Investment;
4. Fiduciary information, including non-exempt transactions between the plan and parties-in relationships with the plan);
5. Transactions in excess of 5 percent of the plan assets;
6. Insurance information including sales commissions paid by insurance carriers; and

7. Information regarding any common or collective trust pooled separate accounts, master trusts or 103-12 investment entities in which the Plan participates.

You also have the right to receive from the Plan Administrator, on request and at no charge, a statement of the assets and liabilities of the Plan and accompanying notes, or a statement of income and expenses of the Plan and accompanying notes, or both. If you request a copy of the full annual report from the Plan Administrator, these two statements and accompanying notes will be included as part of that report. The charge to cover copying costs given above does not include a charge for copying of these portions of the report because these portions are furnished without charge.

You also have the legally protected right to examine the annual report at the main office of the Plan, 201 North Main Street, Jacksonville, Illinois and at the U.S. Department of Labor in Washington D.C. or obtain a copy from the U.S. Department of Labor upon payment of copying costs.
